
Subject: e-mail representation dated 09.02.2023 and 15.2.2023 received from M/s Inkarp Instruments Pvt. Ltd. Hyderabad on the technical specifications of NIT for NanoBio Spectrophotometer.


Purchase committee has gone through the Note dated 24.02.2023 of the Technical Sub Committee which related to above subject and reference. The matter was discussed with the IO/PL who has reiterated the TSC recommendations. IO/PL has also informed that this equipment is necessary for his R&D activities which are related to the study of DNA/RNA/protein/kinetics and thus recommended not for retendering which may be time consuming.


In view of the above, PC observes that the corrigendum for point 12 of NIT may be published on CPP Portal, Institute's web site, potential bidders, concerned embassies and CSIR Labs/Instts. for wider publicity. Intimation may also be given to M/s Inkarp Instruments Pvt. Ltd. Hyderabad PC also recommends that the time extension for two weeks for bid submission may be permitted from the date of bid submission that is 01.03.2023, IO/PL will provide the e-mail ids of the potential bidders for sending the above intimation.


Director is requested to kindly permit the extension of two weeks for the bid submission from 01.03.2023 as recommended above.


